

# **HERTFORDSHIRE CRICKET LEAGUE**

## **SCORER REGISTRATION PROCESS FOR 2023**

### **Background**

Under Match Rule 3 for the Premier Division and the Championship, and Match Rule 8 for Divisions 1, 2A and 2B, scorers must either be qualified at ECB ACO Level 1 or have obtained dispensation from this requirement from the League. Each club with a team playing in these Divisions is required to register with the League every scorer attached to the club who may be appointed to score such matches.

### **Registration Procedure**

The registration of scorers will follow a similar process to that used to register umpires. Within the Registration area of the League website you are required to enter the name of each scorer attached to your club, and indicate which of the following applies:

<b>Qualified</b>	A scorer who has gained an ECB ACO scoring qualification at Level 1 or higher.
<b>Dispensation Granted</b>	A scorer who has received dispensation from the League from the requirement for qualification. Note that completion of the ECB ACO Club Scorer course will be accepted as grounds for dispensation, but will not meet the criterion for "Qualified".

### **Request for Scorer Dispensation**

A club seeking to obtain dispensation is required to complete the form "Request for Scorer Dispensation Under Match Rule .." for each scorer for whom dispensation is being sought. The form must be signed by the scorer and by the Club's Chairman or Secretary, and sent to Hilary Stiffin at [hilary.stiffin@ntlworld.com](mailto:hilary.stiffin@ntlworld.com) on behalf of the Umpires and Scorers Sub-Committee of the League.

Please provide the details requested on the form, particularly concerning the scorer's experience as both a player and scorer. We are looking for sufficient evidence of competence to allow a scorer to officiate in matches despite not having completed an ACO Level 1 qualification. The objective is to improve standards of scoring and not to prevent experienced scorers from continuing to officiate in matches.

It is an ECB requirement that all scorers must have a current DBS certificate obtained through cricket. If this is not the case, dispensation will not be given unless it is stated that a DBS application has been made.

Please note that the dispensation will apply to the current season only.
